
Everything has an identity Human & machine identities are multiplying Identities must be secured





Identity and Access Data is Siloed

- Lack of visibility
 - Who are my identities, external identities?
 - Who can access production?
- Unable to Detect Threats such as:
 - Identity based attacks (brute force, session hijack)
 - Privilege escalation paths
- Operational Overhead due to:
 - Lack of visibility extends time to detect, investigate, and prioritize
 - Long time to respond to identity threats



The Action Plan

Implement processes for J/M/L and to automatically Phase 2: **REGULATE** detect and remediate violations Define Rules and Roles Phase 1: **DISCOVER** Get visibility over all Network segments Phase 0: **HIGH RISK** Recognize risk Governance, Risk & Compliance & plan for action **Environments** Identities

Access Control
